#### PDG Bill Blankenship

It is with great sadness that we mourn the passing of PDG Bill Blankenship (2006-07) of Kingsland. PDG Bill, a member of The Rotary Club of Camden County, passed away on Sunday, Jan. 13.

In lieu of flowers, the family wishes donations to be made to GRSP, P.O Box 61327, Savannah, GA 31420. Individuals wishing to send cards can send them to Bill's son and his wife, David and Christine Blankenship, at P.O. Box 1626, Kingsland, GA 31548. Simplified Grants program. District Simplified Grants are a tool for Rotary districts to support short-term humanitarian projects that benefit the community. Districts can request up to 20 percent of their District Designated Fund (DDF) for a grant to support multiple projects locally or internationally.

Clubs receiving the grants, their project and the total grant amount awarded are:

The Rotary Club of Eastman -The \$5,000 District Simplified Grant awarded to The Rotary Club of Eastman will be used to purchase interactive white boards with overhead video projectors. This will allow information from the Internet and data to be shared with the entire class at the same time. According to the club's application, the grant also will enable the purchase of electronic assessment tools to instantly check student understanding on a topic and have a class summary displayed immediately so the teacher knows when the class needs remediation or has achieved mastery.

The Rotary Club of Hinesville will use it's \$5,000 award to support diagnostic lab work and referral appointments for indigent patients at a community health center in Liberty County. The health center accepts patients from surrounding counties based on income and serves people living in poverty and without transportation.

The Rotary Club of Savannah Sunrise is involved in a project that focuses on an inner-city Savannah neighborhood where the average income is below poverty level. The neighborhood community center is a safe haven for seniors and youth, with youth receiving weekday dinners at the center and school meals. However, there is no access to nutritious food on weekends or during vacations from school. The \$3,000 District Simplified Grant will provide weekend backpacks for kids and four white polo shirts for school uniform requirements. The program will also assist seniors and others with the purchase of groceries.

The Rotary Club of Tift County received a \$2,750 grant to help offset expenses of its summer literacy program, held in conjunction with the Housing Authority and the Tift County Foundation for Excellence. There will be an on-site teacher, meals and learning incentives. The funding will assist with the purchase of computers for an Accelerated Reader program and will involve school children and other Housing Authority residents.

The Rotary Club of Warner Robins received a \$1,500 grant to help with the distribution of 2,000 dictionaries to every third grade student in the county. Each dictionary includes math, science, world maps and geography assistance. Rotarians will personally distributed the dictionaries to each third grader in the county.

A \$2,750 grant for The Rotary Club of Wrightstville will enable the club to offer a program that will reach out to Alzheimer's patients, second grade students and Boy Scouts. Dolls will be provided by Rotarians for Alzheimer's patients to be adopted by club members. Additionally 4-Way Test coloring books and a read-along CD will be provided to all second graders and books will be given to youngsters in Pre-K 5 classes. The Rotarians also will participate in classroom reading activities and provide tents for Boy Scouts.

The Rotary Club of Macon will receive \$2,000 to support reading activities in the Bibb County Schools.

The Rotary Club of Skidaway Island also will receive \$2,000 to fund a computer technology center for indigent students in Savannah.

A \$1,000 grant was awarded to The Rotary Club of Sylvania.

# **Speech Contest Dates Announced**

An important part of this year's continued focus will be on the Rotary High School Speech Contest, which was certainly a focal point at last year's district conference.

"This year should be even more exciting," said Kelli Simon, District 6920 speech contest chair. "With each year, the competition gets greater and the speeches get better!"

As in past years, each club president or his/her appointee, is asked to contact each local high school within the club's service area and ask them to select a speaker to represent their high school with a speech using this year's Rotary theme as the basis. The theme this year is "Rotary Shares" and the top two students from each club will go on to compete at the zone level which will increase the level of competition substantially.

The school representatives will deliver the speech at the local Rotary club assembly, at which time a first and second place winner will be selected to represent the club at the designated zone speech contest. The winners of the zone contests are expected to speak at the District Conference on Saturday, April 19, in Macon.

Each zone winner will be awarded a \$1,000 scholarship contingent upon the students presenting their speech at the District Conference.

Final selection of your club's representative should be done no later than Feb. 28, with zone competitions being held in March. The East Zone competition will be held in Statesboro on March 1; the North Zone competition will be held in Dublin on March 15 and the Central/ West Zone will be held in Douglas on March 29.
