March is Literacy Month

In 1985, Rotary International declared basic literacy to be a pre-condition to the development of peace. More than 800 million people worldwide are unable to read or write creating a lack of skills that makes them especially vulnerable to hunger, disease, and extreme poverty. For a child, knowing how to read can be the difference between healthy self-esteem and none at all. For a teenager, it can mean staying in school rather than dropping out. And for an adult, it often means a steady income, versus a lifetime of struggling to feed a family. Literacy empowers people and is essential for community development as literate populations are more likely to develop economically, live healthier lives, and be more peaceful. Child mortality is also closely linked to literacy rates. When women and girls are educated, they are generally better equipped to access resources and make decisions that improve the lives of their children and families. When President D. K. Lee introduced the 2008-2009 theme last year, he said that "We will Make Dreams Real by making sure that more children have a chance to go to school, because it will only be through education that the deadly cycle of poverty can be broken."

Earlier this month, the first ever Multi-District Literacy Conference was held at The Carter Center in Atlanta where Rotarians from all three Georgia Districts joined together to learn and share literacy ideas and projects that have been successful in our Georgia Rotary clubs. District 6920 was represented by seven Rotary clubs during the full day conference. The Rotary Club of Skidaway Island, featured by their club representative, Susan Kleine, shared the success their club has provided with the development of the Lockamy Technology Center in Savannah, Georgia. This technology center has been highly recognized by the county school system and named in honor of

Dr. Thomas Lockamy, local school superintendent. Dolly Parton Teams with Rotary International & Ferst Foundation to Promote Early Childhood Reading

Entertainment legend and philanthropist Dolly Parton announced a groundbreaking partnership between her Dollywood Foundation and Rotary International to promote early childhood reading. The result of the partnership will be a statewide expansion of Georgia's Ferst Foundation for Childhood Literacy. Preschool children in every county will one day receive age appropriate books to better prepare them for reading and learning success.

In an agreement approved by the leadership of Rotary International and the Dollywood Foundation, Rotary clubs in the United States, Canada and the United Kingdom will support the Dollywood Foundation's Imagination Library program, which provides books to children from birth until they enter kindergarten. Through the joint leadership of all three Georgia Rotary District Governors, all Rotary clubs in the state will be encouraged to participate and raise funds for the Ferst Foundation in the expanded program.

Ms. Parton made the announcement at the AmericasMart in downtown Atlanta. Rotary Foundation Trustee John Germ and the founder of the Ferst Foundation, Robin Ferst, along with Governor Ted Propes from District 6900, Governor Gary Moore from District 6910 and Governor Kenan Kern from District 6920, joined Ms. Parton on stage. "We have dreamed of this day since we mailed our first books to children in Morgan County in 1999," Ms. Ferst said.

"We've strived to reach every child under the age of 5 in Georgia and now with Dolly's support and the leadership of Rotary International we are finally within reach of that goal."

Ms. Parton grew up in an underprivileged Tennessee community where many around her lacked the literacy skills she developed through her personal love of books. From that experience she started the Imagination Library, which includes 60 classic childhood books such as "The Little Engine That Could." Ms. Parton's foundation now sends 500,000 books each month to children at risk of falling behind their peers because they lack exposure to reading and age appropriate material at an early age.

Ms. Parton's program has been an inspiration to many, including Ms. Ferst, a fourth generation philanthropist in Atlanta who created the Ferst Foundation for Childhood Literacy in 1999. Ms. Ferst's goal is to emulate Ms. Parton's Tennessee success in Georgia. Rotary clubs will help Ferst expand the Foundation's presence in Georgia from 64 counties now (representing 42,000 books a month) to all 159 counties.

The Ferst Foundation encourages children to dream and learn through reading, promoting family involvement in achieving early school success for children.

"We are thrilled to have Dolly's support and the support of Rotary International," said Midtown Atlanta Rotary club's president Barbara Rose. "We believe Georgia's Rotary clubs are key to providing structured leadership across the state to ensure success. We now have the tools needed to break the cycle of illiteracy in Georgia. Our job as Rotarians is to elevate this issue to a new level of consciousness and activate our communities to address this often hidden menace."

Rotary Marks Peace Day With Ceremony

Members of the Rotary Club of Milledgeville gathered in front of the Baldwin County Courthouse recently to mark its annual Peace Day observation. members and local residents Club converged to celebrate Rotary International's World Understanding and Peace Day at the site of the monument donated by Rotary and erected in 1996. The Milledgeville Rotary Club helped Baldwin County become the first Rotary Peace Community in the United States on Sept. 5, 1995. The following year, through the efforts of the Rotary club, The Peace Monument, located at the right front of the Baldwin County Courthouse, was dedicated. Each year, in February,

Rotary International observes the Annual World Understanding Month. The Milledgeville Rotary Club combined the Peace Day observance with the 104th Rotary anniversary in the community. Those gathered Thursday listened to music provided by the Baldwin High School Band, and members of the BHS ROTC presented the colors. Rotary president Keith Drinkwater welcomed those gathered. Past president Arthur Gunn gave the invocation and welcomed Rotary District Governor Kenan Kern who introduced the guest speaker for the day, Brig. Gen. Stewart Rodeheaver. While serving in the U.S. Army, Rodeheaver was responsible for large portions of Baghdad, Iraq, during his deployment with the



48th Brigade, which is preparing for an upcoming deployment. Thursday, he spoke of the importance of working toward peace and directly addressed building peace.

"Conducting war is a nationto-nation business application," Rodeheaver stated during his presentation. "Spreading peace is a person-to-person business application."

General Rodeheaver's theme focused heavily on the nature of relationship building and success in helping Iraq heal, but he also took the time to thank U.S. veterans for their service to their country. "To all of you who have served," Rodeheaver said, "and to all of you who have worn the uniform: *Thank you*."

At the January Trustees meeting, a decision was made to reduce the 2008-09 Matching Grant budget in order to conserve The Rotary Foundation's World Fund. As of 2 March, the Matching Grant budget has been fully committed, and the Trustees are unable to approve any additional grant applications.

As a result of the budget reductions, no new **Matching Grant** applications will be accepted in the 2008-09 Rotary year. New applications received by the Foundation will be returned to the sponsors without processing. Applications that were received by the Foundation before the commitment of the available budget will remain at the Foundation and can move forward for processing in the 2009-10 Rotary year. Humanitarian Grants staff are in the process of notifying the sponsors of these applications, and their district leadership, of these updates.

At their April meeting, the Trustees will evaluate the current financial situation and approve a budget for 2009-10. Detailed information about Matching Grant funding will be available after the meeting, and the Rotary International Web site will be updated with all pertinent information. 

End Polio Now Exhibit Opens at RI Headquarters

Rotarians and others who visit RI World Headquarters in Evanston, Illinois, USA, will find the **End Polio Now** exhibit unveiled recently. This exhibit offers a compelling look at the global effort to eradicate polio.

"This exhibit serves as a reminder to those who live in a polio-free world about the suffering of those who do not," Rotary Foundation Trustee Vice Chair Ron Burton told a gathering of Foundation Trustees, Major Donors, Rotary representatives to the United Nations, and the senior adviser in the Global Health Program of the Bill & Melinda Gates Foundation, Cheryl Scott, as well as the media.



The exhibit features 12 large panels with photographs and text, a continuous video presentation, and displays of items used to promote and carry out National Immunization Days, such as a Rotary volunteer's cap, Kick Polio Out of Africa soccer ball, and cold box for transporting oral polio vaccine. Also on display are a few of the many awards Rotary has received in recognition of its leadership role in the global effort to end polio.

The last panel — Help Meet the Challenge — highlights Rotary's US\$100 Million Challenge in response to the Gates Foundation grant for polio eradication. Visitors can use an electronic kiosk in front of the panel to donate to Rotary's challenge.

Burton called the exhibit, which will run for five years, "a tribute to the will and determination of the world's 1.2 million Rotarians. . . . This exhibit tells their story — a story of perseverance and hope in the face of financial, political, technical, and geographic obstacles.

Future Vision Plan The Rotary Foundation

- What changes are being made to the Foundation recognition programs?
- 1. Paul Harris Fellow medallions will not be provided automatically but will be available for purchase. (Costs not available at this time)
- 2. The individual donor will be the only person authorized to transfer Foundation recognition points.
- 3. Foundation recognition points will expire upon the death of the donor or the death of the surviving spouse of a Major Donor (US\$10,000+).
- 4. Foundation recognition points and recognition amounts will only be transferred for transactions of 500 points or more.
- 5. New wearable recognition will be issued to Arch C. Klumph Society members.
- When will changes to the recognition process take effect? The new policies take effect 1 July 2009.
- When will the new wearable recognition be available? The Arch C. Klumph Society pins should be available by late December 2009.
- Why are these changes being made? It has long been the wish of The Rotary Foundation Trustees to simplify the Foundation's programs and allow more resources to meet donors' expectations. The Future Vision Plan and these changes are intended to simplify the recognition program and, therefore, make the Foundation a more efficient, timely, and cost-effective steward of the gifts of many Rotarian and non-Rotarian donors.

 Will club presidents still be able to transfer Foundation recognition points from members' IDs?

Historically, Rotary club presidents have been allowed to authorize transfers of Foundation recognition points from the IDs of current and former members of their club. Once this change is implemented, only the individual donor may transfer Foundation recognition points from their ID.

- What does it mean that Foundation recognition points expire upon the death of the donor or the death of the surviving spouse of a Major Donor? Because only the donor will be authorized to transfer Foundation recognition points, any remaining points will expire after the donor's death. A surviving spouse of a Major Donor, however, may still authorize transfers on the donor's behalf.
- What does the new 500 point threshold for transfers mean? Though individuals, clubs, and districts may still transfer Foundation recognition points to name new Paul Harris Fellows and present further Paul Harris recognition awards, the minimum transfer from an account will be 500 points. Transfer requests of less than 500 points, or Paul Harris Fellow recognition amounts, would not be processed.
- What does it mean that Paul Harris Fellow medallions are available for purchase? The standard recognition materials will no longer include the current Paul Harris Fellow medallions. This item is optional and will be shipped only by special order. Recognition practices will be assessed on an ongoing basis to ensure the goals of the organization are achieved.
