New Procedures for Reinstatement of Tax-Exempt Status Introduced

Tax-exempt organizations that have had their tax-exempt status automatically revoked because they failed to file required annual returns for three consecutive years have new procedures for getting their exempt status reinstated, under guidance issued by the IRS on Thursday (Rev. Proc. 2014-11). Earlier guidance providing methods for reinstating exempt status (Notice 2011-44) is modified and superseded.

Organizations that are exempt from tax under Sec. 501(a) and private foundations under Sec. 4947(a)(1) are required to file an annual return with the IRS or, if their annual gross receipts are normally \$50,000 or less, an annual notice (Form 990-N, e-Postcard). Any organization that fails to file the required annual return or notice for three consecutive years has its tax-exempt status automatically revoked under Sec. 6033(j)(1) and must reapply to the IRS to have its exempt status reinstated.

The new procedures include a streamlined retroactive reinstatement process for organizations that were eligible to file either form Form 990-EZ, Short Form Return of Organization Exempt from From Income Tax, or Form 990-N during the years they failed to file. There are also different retroactive reinstatement processes for organizations to use within 15 months of the revocation of their exempt status and beyond 15 months. And finally, the IRS is also introducing a "post-mark date" process, under which, if an organization does not seek retroactive reinstatement, it can instead apply for reinstatement from the postmark date of its application.

Under the streamlined procedure, the organization will have to attest that its failure to file was not intentional and that it has put procedures in place to file in the future. Organizations that are not eligible for the streamlined procedure and are applying for reinstatement within 15 months of revocation will have to provide facts that support their claim that the organization had reasonable cause for failure to file for at least one of the three consecutive years it failed to file.

Organizations that are applying for reinstatement 15 months or more after revocation will have to provide facts that support the claim that the organization had reasonable cause for failure to file for all three of the consecutive years it failed to file.

Organizations will be required to file annual returns for the years they did not file (except if they were required to file Form 990-N), and, if their application for reinstatement is approved, the IRS will waive failure-to-file penalties for those years.

Effective date and effect on prior applications

The new procedures are effective for applications filed after Jan. 2, 2014, but the IRS says it will also apply the new rules to pending applications, if that will benefit the organization. Organizations that previously had their tax-exempt status reinstated effective from the date of their application, but that would have been eligible for retroactive reinstatement under the new streamlined procedure, will be reinstated effective from their revocation date. Organizations that previously had their tax-exempt status reinstated effective from the date of their application and that would have been eligible for retroactive reinstatement under the other two new procedures may reapply for retroactive reinstatement.



Interested in Participating in a National Immunization Day?

The following is a reprint of an email from Past RI Director Brad Howard announcing a new trip.

Dear District Governor:

The purpose of this correspondence is to announce our trip to India to participate in the February, 2014 polio National Immunization Days (NID). Attached is a document that provides specific information about the trip, including a means of registering for the program.

Please feel free to share this information with the Rotarians and clubs in your District as soon as possible as we have a limited amount of space and expect this trip to be filled within the next week or two.

Since January 2011, there has been only ONE new confirmed case of polio in India. In 2012, India was removed from the list of polio endemic countries. We are getting remarkably close to eradicating polio globally. Therefore, this might be one of the last opportunities we will have to organize a trip to India to participate in polio NID activities. This trip offers you and the Rotarians in your club and District an extraordinary opportunity to have an experience of a life time.

The following summarizes the key trip information:

- * Our program will travel to Delhi, India, where we will participate in the polio NID activities and attend the Polio Conclave. This trip also includes travel to Agra to visit the Taj Mahal, and Jaipur to visit the famous Rotary Jaipur Limb factory, and enjoy this extraordinary city.
- * Date of Departure: Friday, February 14, 2014
- * Date of Return: Tuesday, February 25, 2014
- * Per Person Cost, based on double occupancy: \$2,299. This price does not include international, roundtrip airfare or Indian visa fees. However, it does include hotels, transfers, the Polio Conclave and other Rotary events, participation in the NID activities, most meals, sightseeing, English speaking guide and other items as stated in the attached document.
- * Air Reservations: Participants are free to secure their own air reservations using their frequent flyer mileage, or individual purchase. Howard Tours will be happy to help you purchase airline tickets, which can be requested on the trip application.
- * Visas: All U.S. citizens will need to secure an Indian visa. We will give our members specific information about how to secure the visa when we send the confirmation documents. It is important that our tour do not attempt to secure the Indian visa before receiving our information.

*Travel Vaccines: We recommend that all participants visit the Centers for Disease Control Web site: http://wwwnc.cdc.gov/travel/destinations/india.htm to determine what vaccinations may be needed for this trip. We suggest that members visit this web

site, print out the material and visit a doctor, or travel doctor, to determine what vaccinations or treatments may be needed for this trip.

This group will be limited to approximately 35 people, and confirmation in the program will be on a first come, first served basis. To join us, please complete and sign the application on page five of the attached document. Please make sure to include the requested credit card authorization for the cost of the program. Over the last two years, this program sold out in less than two weeks.. We expect the same response this year. If you are planning to join us, we suggest immediate action.

We look forward to having you or Rotarians from your District join us.

The Daughters of the American Revolution Sukey Hart Chapter of Warner Robins acknowledged two Houston County citizens on Dec. 14 at Houston Lake Country Club for their service and dedication in the community.

Honored were Jack Steed with the DAR Community Service Award and Micah Crews with the Historic Preservation Recognition Award for his leadership and dedication in helping conduct a massage cleanup of the Fredrick Cemetery in Warner Robins.

Steed, whose roots with the DAR date back to 1930s, said that being recognized by the DAR organization, is meaningful to him.

"It means a lot to me because I have always admired the Daughters of the American Revolution and the work that they do," Steed said. "It's one (award) I am really appreciative of and it's a great organization. (Saturday's event) was really nice, professionally done and I admired the recitations they had done."

Kathy Hart, chairman of the Community Service Committee, Sukey Hart Chapter, National Society Daughters of the Americans Revolution (NSDAR), presented Steed with his award saying Steed is deserving.

"Jack is an extremely patriotic and caring individual," Hart said. "He has been recognized by many groups and I am proud to present Jack with the coveted NSDAR Community Service Award."

Over his lifetime, Steed has been involved heavily with the military, first enlisting in U.S. Air Force in 1949 and serving as a Air Traffic Controller, Personnel Superintendent and as a First Sergeant. In total, Steed gave 33 years of service. He has also been a part of the Rotary Club of Centerville, and currently remains active with the National Air Force Association, where he currently serves as a National Director, Emeritus.
